I am **xxxx**, son of **xxxx** and **xxxx**. I was born on 13th September 2002 and including my grandma, i have 4 family members.

After successfully completing my high school education at Ekta Academy with a 3.17 GPA and my secondary education at Himalayan Secondary School with a 3.4 GPA, I decided to enrol in the **Diploma of Business leading to Bachelors of Accounting program at Swinburne University of Technology** in Australia. The degree I want to earn is offered in other nations, but I decided to study in Australia because it has a low crime rate, great facilities, good communication, environment and affordable tuition.

These are the factors that drove me to this program.

- Can gain variety of careers options in business.
- Can find employment opportunities virtually in any industry.
- High earning potential as an accountant.
- Can fast-track career with an online accounting degree.

I had to deal with a two-year academic gap after high school because of the CORONA VIRUS's effects. I enrolled in Image Education Foundation's one-year Advanced Diploma Computer Application training program during that period. They have also arranged an **education loan worth of NPR 40,00,000 (Equivalent to 47,264.07 AUD)** from Siddhartha Bank Limited. These figures will undoubtedly enable me to pay for my schooling and other expenditures while on a visa in Australia.

As the sole heir left to safeguard and bear responsibility for the family's assets and heirlooms, which are all located in Nepal, I shall return there after I graduate. I won't ever have to worry about finding a job or making ends meet because this degree will give me a wide range of career and work alternatives.
